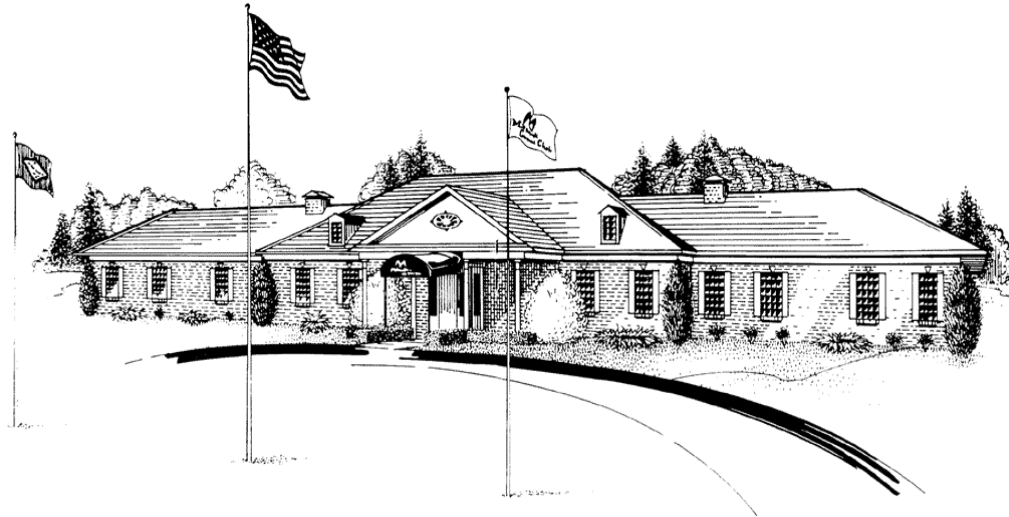

RESIGNATION

PAYMENT OF ACCOUNT
